The Department of Safety and Inspections (DSI) has recommended suspension of the Auto Repair Garage license held by Pronto Auto Repair Inc. d/b/a Pronto Auto Repair for the premises located at 1054 Payne Avenue in Saint Paul. The basis for the recommendation is as follows:

On February 27, 2023, you were sent a NOTICE OF CITY COUNCIL ACTION from the Department of Safety and Inspections requesting payment of the \$500.00 matrix penalty imposed by City Council on February 22, 2023 (RES PH #23-267).

The penalty was imposed because an inspector from the Department of Safety and Inspections documented five (5) violations to your license conditions during re-inspection of the licensed premises on November 17, 2022.

You were given until Friday, March 24, 2023, to pay the \$500.00 matrix penalty. As of today, that penalty has not been paid.

You have three (3) options to proceed:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **April 14, 2023**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council agenda for approval of the proposed remedy.

2. You can pay the \$500.00 Council imposed matrix penalty. If this is your choice, you should make payment directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **April 14, 2023**. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered a waiver of the hearing of which you are entitled.
3. If you wish to admit the facts but you contest the penalty, you may have a hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a hearing no later than **April 14, 2023**. The matter will then be scheduled before the City Council to determine whether to suspend your Auto Repair Garage license. You will have an opportunity to appear before the Council and make a statement on your own behalf.

If you have not contacted me by April 14, 2023, I will assume that you do not contest the suspension of your Auto Repair Garage license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.

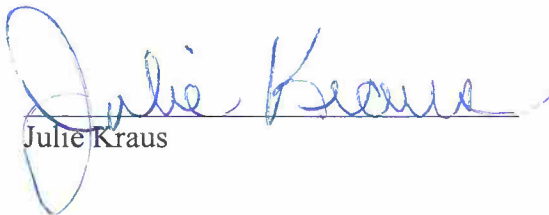

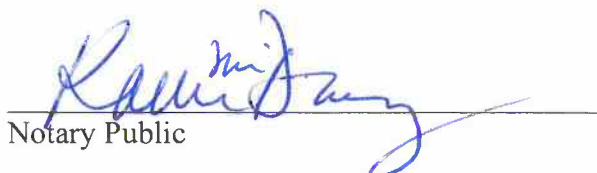

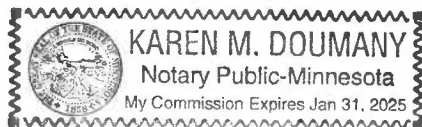

Approving the adverse action against the Auto Repair Garage license held by Pronto Auto Repair for the premises located at 1054 Payne Avenue.

WHEREAS, the Auto Repair Garage license ("License") held by Pronto Auto Repair (Licensee), under License ID #20130001947 for the premises located at 1054 Payne Avenue in Saint Paul (Licensed Premises) was the subject of a Notice of Violation ("Notice") dated January 9, 2023; and

WHEREAS, the Notice stated that, during a complaint-based inspection of the Licensed Premises on October 24, 2022, an inspector from the Department of Safety and Inspections (DSI) observed and documented eight (8) license condition violations; and

WHEREAS, on October 27, 2022, DSI sent the Licensee a Correction Notice detailing these violations and giving the Licensee until November 11, 2022, to bring the Licensed Premises into compliance with their license conditions; and

WHEREAS, on November 17, 2022, the inspector returned to the Licensed Premises for a re-inspection and observed and documented with photographs five (5) license condition violations; and

WHEREAS, under the penalty matrix contained in section 310.05 (m) of the Saint Paul Legislative Code, the presumptive penalty for a first-time violation of license conditions within a period of twelve (12) months is a fine of \$500.00; and

WHEREAS, because this is the Licensee's first violation of their license conditions within a period of twelve (12) months, the licensing office recommended a \$500.00 penalty be imposed against the Licensee; and

WHEREAS, the Notice stated that if the Licensee failed to pay the \$500.00 penalty or request a public or administrative hearing by January 24, 2023, that the matter would be placed on the next available consent agenda to impose the recommended penalty; and

WHEREAS, the Licensee did not respond to the Notice by January 24, 2023, to pay the \$500.00 penalty or request a public or administrative hearing; now, therefore, be it

RESOLVED, the Auto Repair Garage license held by Pronto Auto Repair under License ID #20130001947 for the premises located at 1054 Payne Avenue in Saint Paul is hereby ordered to

pay a matrix penalty of \$500.00 for five (5) license condition violations observed and documented by a DSI inspector during a complaint-based inspection of the licensed premises on November 17, 2022.

Payment of such penalty shall be made within thirty (30) days of the date of the adoption of this resolution.
