I live fulltime in the Blair House
directly across Selby Ave from
the Handsome Hog at 173 Western Ave. N.

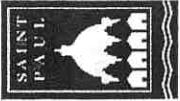
Concerns: (1) I am very concerned about the changes
to their license as I have repeatedly
witnessed their previous history of
lack of or struggle to monitor noise
and patrons during open hours and
after closing.

(2) I hear and watch groups of people congregate outside their doors on the corner of Selby and Western smoking, drinking, ^{and} ~~repeatedly~~ driving loud cars by and even sometimes pushing one another into the street during and after Handsome Hog "abuses." This is especially a problem during Summer weather.

(3) I hear and watch groups of individuals in the outdoor patio area after Handsome Hog closes its gates but people linger. This repeatedly happens even though they have promised and testified to have people vacate the premises. (4) They say on the application that they closed the patio at 10pm but even with gates closed, patrons linger inside and outside until much later, (5) If one goes inside and asks they say they are open until 11pm.

Please address these concerns for better resolutions for those of us who permanently live close to Handsome Hog and its ~~patrons~~ patrons.

If objections are received, a hearing will be scheduled before a legislative hearing officer. If you have sent in an objection, you will receive notice of the time, place and date of the scheduled hearing. At that hearing, the Legislative Hearing Officer will take testimony from all interested persons. At the end of this hearing, the Legislative Hearing Officer will make a recommendation to the City Council as to whether the license request should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny the license.

Recommended License Conditions:

1. Licensee agrees to operate the establishment in compliance with Section 409.02 of the City of Saint Paul Legislative Code as a "Restaurant".
2. Licensee agrees to close the establishment at 12:00 a.m. midnight. All patron/customers shall vacate the premises by 12:30 a.m. each day of the week as per City Zoning Code (parking requirement) and Section 409.02 of the City of Saint Paul Legislative Code.
3. Any outdoor activities related to an outdoor seating area shall comply with applicable State and Local rules and regulations, including but not limited to Chapter 293 Noise Regulations of the City of Saint Paul Legislative Code.
4. Licensee will create a video surveillance camera and lighting placement plan (video surveillance plan) for the parking lot at 401 Selby Ave associated with the licensed premises. License holder will submit the video surveillance plan to the Saint Paul Police Department (SPPD) liaison with the Department of Safety and Inspection (DSI) for review and approval. In accordance with the approved video surveillance plan, license holder will ensure that video surveillance camera system is in good working order, ensure it is recording 24 hours per day, ensure it can produce recorded surveillance video in a commonly used, up-to-date format, and ensure that accurate date and time of day are visible on all recorded video. License holder will retain surveillance video for a minimum of thirty (30) days. If an incident is deemed serious by SPPD, license holder shall make surveillance video immediately available for viewing by SPPD. If a copy of the surveillance video for a serious incident is requested by SPPD, license holder shall have the technology, materials and staff available to immediately make the copy. In all other cases, license holder shall provide a copy of the surveillance video to the requestor within 48 hours.
5. The outdoor patio seating area shall close by 10:00 p.m. each day of the week.
6. Licensee will retain an acoustic engineer to perform a noise impact analysis and follow all recommendation for mitigation of noise impacts in compliance with state and local rules and regulations.
